# TERMS OF AGREEMENT

## For Budget Customers:

1. Credit approval required for new EZ Pay Budget Plan customers.
2. All fuel deliveries will be made on an automatic delivery basis and the tank will be filled completely each time.
3. This agreement is exclusive of any applicable taxes.
4. No discounts can be used in combination with this offer.
5. The EZ Pay Budget Plan shall renew automatically unless terminated in writing by either party.
6. This agreement is not subject to any act of any governmental authority related to supply or price. The agreement is also not subject to market conditions nor any natural phenomenon, strike, embargo, disaster or act of God, which may interrupt, limit or halt the supply of fuel, temporarily or permanently. No claim shall be made under this contract for special or consequential damages.
7. This contract shall not be transferred or assigned by the customer in whole or in part directly or indirectly to any other party or delivery location.
8. We reserve the right to alter your EZ Pay monthly payment amount based on increased or decreased consumption and market pricing.
9. Written notification is required to cease automatic deliveries.
10. Customer agrees to notify the company, in writing, prior to moving or selling property and prior to their final oil delivery. If the company delivers fuel oil without prior termination, it is the customer's responsibility to pay for the acquired fuel oil in full.
11. Auto pay by EFT & credit cards are processed on the first of every month.

## For Pre-Buy Customers:

1. All fuel deliveries will be made on an automatic delivery basis and the tank will be filled completely each time.
2. PreBuy pricing begins on **9/1/23**. Deliveries made before that date will be billed at the market rate. PreBuy customers that opt out of Automatic Delivery at the end of PreBuy gallon supply will be receiving a full tank upon that last delivery and must contact our office PRIOR to that delivery occurring. If customer exceeds their PreBuy gallons purchased and requires more oil before the end of the program year, we will charge the market rate posted on [HarnedDurhamEnergy.com](http://HarnedDurhamEnergy.com) on the day of delivery.
3. Please be aware that **NO REFUNDS** will be made. Any PreBuy gallons remaining at the end of the PreBuy Contract (**5/31/24**) will be converted into gallons based on the per gallon PreBuy price in place as of **6/1/24 or later**. This may result in more or less gallons remaining on your account depending on the new per gallon PreBuy price.
4. No discounts can be used in combination with this offer.
5. PreBuy gallons are available for purchase while supplies last.
6. This agreement is valid through **5/31/24**, unless otherwise noted.
7. Written notification is required to cease automatic deliveries.
8. Customer agrees to notify the company, in writing, prior to moving or selling property and prior to their final oil delivery. If the company delivers fuel oil without prior termination, it is the customer's responsibility to pay for the acquired fuel oil in full.
9. Payment by credit/debit card or EFT will be processed when this form is received.
